TERMS AND CONDITIONS

1. Website Terms & Conditions of Usage

1.1 Limited Liability of SMS Cellular Services and The eWarehouse: The User understands, acknowledges and agrees that usage of the Website and Services is at the sole discretion and risk of the User. SMS Cellular Services and The eWarehouse reserves the right at any time to change or discontinue any aspect or feature of the Website or Services, including, but not limited to, content, hours of availability, products, Services offered and equipment needed for access or use the Website. Notwithstanding the effort placed on maintaining the availability and accessibility of the Website and Services, SMS Cellular Services and The eWarehouse takes no responsibility for, and will not be liable for the Website or Services being temporarily unavailable or inaccessible for whatsoever reason.

1.2 No Warranty: The information contained on the Website and the Services provided via the Website is provided by SMS Cellular Services and The eWarehouse and/or its partners, members, suppliers or agents without warranty of any kind, express or implied, including (but not limited to) any implied warranties of reliability, fitness for any particular purpose, timeliness, sequence, completeness, non-infringement of third party rights and/or freedom from errors or inaccuracies.

and be interpreted in accordance with the law of South Africa and the User consents to the jurisdiction of the Grahamstown High Court in the event of any dispute. Any dispute regarding this Agreement or the Services that cannot be resolved between the Parties, shall however, first be referred to confidential arbitration in terms of the rules of the Arbitration Foundation of South Africa prior to proceeding to Court and such arbitration shall be conducted in English. 3. Privacy Policy

3.1 Privacy and Personal Information: SMS Cellular Services and The eWarehouse endeavours to comply with all laws and regulations including the 1996 South African Constitution and other legislation providing for privacy. As such, SMS Cellular Services and The eWarehouse seeks to ensure the quality and accuracy of personal information in its possession and under its control, and also, to ensure that all existing and new personal information is collected and processed in compliance with South African law.

3.2 Personal Information Collected, Principle of Minimalism & Purpose of Collection: Please be assured that the privacy of SMS Cellular Services and The eWarehouse customers and Users of our Website is of the utmost importance to SMS Cellular Services and The eWarehouse. The SMS Cellular Services and The eWarehouse Website collects, processes and stores personal information of its customers and Users of the Website subject to the following principles:

- **3.2.1** Relevant and minimal personal information of customers is collected for the purpose of managing Customer's affairs with SMS Cellular Services and The eWarehouse. For the avoidance of doubt, Customers referred to herein constitute persons with valid Accounts with SMS Cellular Services and The eWarehouse and accessing or using the Services, as such Customers shall also constitute Users of the Website. Not all Users however will have valid Accounts with SMS Cellular Services and The eWarehouse and therefore not all Users shall be Customers.
- **3.2.2** Relevant and minimal personal information of Users is collected automatically by SMS Cellular Services and The eWarehouse and its authorised technology agents as a result of User's visits to the SMS Cellular Services and The eWarehouse Website. This information is used to make your visit

to the Website site more efficient, and analysis thereof facilitates improvements made to your experience of the Website. Our agents and service providers may also automatically log your "IP address" which is a unique identifier for your computer or other access device. Further and to the extent necessary, SMS Cellular Services and The eWarehouse may utilise your contact information. Where applicable, personal information submitted by you may be used for communications with you such as marketing or rendering services requested by you from SMS Cellular Services and The eWarehouse. This information may include, without limitation, your name, email address, mobile phone and landline phone details. SMS Cellular Services and The eWarehouse will not edit, disclose or sell any personal information to third parties other than required for the provision of the Services and in the ordinary course of business. You agree that your submission of your personal information indicates your willingness for such information to be used as discussed above.

3.3 Handling of Personal Information: Users acknowledge that records relating to the provision of services and personal information may be required to be retained in terms of law, operational purposes and for evidential reasons by SMS Cellular Services and The eWarehouse and Users expressly agree to such retention and necessary access to such records by authorised SMS Cellular Services and The eWarehouse persons. Users acknowledge further that it is customary and in the normal course of business, for certain communications to be intercepted and monitored while travelling over telecommunication networks (for system health and forensic reasons). Subject to the provisions of the Regulation of Interception of Communications (RIC) Act 70 of 2002, the Customer consents to SMS Cellular Services and The eWarehouse's interception, and monitoring of all communications sent by the Customer to SMS Cellular Services and The eWarehouse. The Customer agrees and acknowledges such consent meets the "writing" requirement as detailed in the ECT Act and the RIC Act. Further, and to the extent necessary, SMS Cellular Services and The eWarehouse may utilise your contact information to provide you with information requested by you in relation to events or new services offered by SMS Cellular Services and The eWarehouse. Your contact information and the contact information of third parties submitted by you may be used for communications such as marketing and distribution of newsletters with you and/or such third parties. This contact information includes without limitation, names, email addresses and/or the name of the respective person's company. In providing information relating to third parties you, the User warrant that you have the right to provide such information. You agree that your submission of your information indicates your willingness for your information to be used as discussed above.

3.4 Disclosure of personal information: SMS Cellular Services and The eWarehouse may disclose personal information:

- **3.4.1** to comply with the law or with legal process
- **3.4.2** protect and defend SMS Cellular Services and The eWarehouse's rights, equipment, facilities, and other property
- **3.4.3** protect SMS Cellular Services and The eWarehouse against misuse or unauthorised use of the Web site; and/ or
- **3.4.4** protect other Website Users or third parties affected negatively by your use of the Website.

SMS Cellular Services and The eWarehouse shall not be obliged to ascertain or provide the identity of the sender of any messages or content.

4. Terms and Conditions of Bulk SMS Services

4.1 Agreements of Sale by Electronic Transaction: The provision of the Service (bulk sms gateway) through the Website constitutes a legally valid transaction between you and SMS Cellular Services and The eWarehouse subject to the terms and conditions specified herein.

4.2 Cancellations of Transactions: SMS Cellular Services and The eWarehouse reserves the right, to refuse to accept, process or honour payment on any order and to cancel any transaction at their discretion including an order for which payment has been received. The reasons may include, without limitation, causes beyond the control of SMS Cellular Services and The eWarehouse, where the "stock" held by SMS Cellular Services and The eWarehouse is insufficient, or not of an adequate quality in the discretion of SMS Cellular Services and The eWarehouse. Should SMS Cellular Services and The eWarehouse cancel the order, as abovementioned, the User shall be entitled to receive a full refund of any monies actually received by SMS Cellular Services and The eWarehouse. Any order cancellations by you will be subject to a deduction of 10% of the total purchase price as an administration fee.

4.4 Anti-Spam: SMS Cellular Services and The eWarehouse subscribes to an "Anti-Spam" policy in respect of the Services provided. In accordance, the Services shall not be used for the sending of unsolicited messages, notifications, alerts, messages or communications. SMS Cellular Services and The eWarehouse automatically monitors all incoming messages for keywords such as "stop", "remove", "delete" and "unsubscribe". If SMS Cellular Services and The eWarehouse detects such a keyword in the contents of communications SMS Cellular Services and The eWarehouse shall delete the relevant number from the Customer's contacts and place the relevant number in a "deleted" inbox. Should the Customer

re-import the number; such number will be filtered out from the import process. In this regard, all Customers of the Service warrant possession of the necessary authority, consent or permissions to enter into communications with the Customer's contacts when using the Service and indemnify SMS Cellular Services and The eWarehouse from any claims against SMS Cellular Services and The eWarehouse by any of the Customer's contacts in respect of unsolicited messages, notifications, alerts, messages or communications.

4.5 Limitation of Liability: Neither SMS Cellular Services and The eWarehouse, nor any service provider appointed by SMS Cellular Services and The eWarehouse shall be held responsible for any injury, loss or damage of any kind whatsoever suffered or incurred as a result of use of the Services including, without limitation, any injury, loss or damage suffered as a result of:
